But remarkable success could not be achieved. Therefore, the four DISCOMs of Odisha propose for a OTS Scheme for liquidating the past dues, those existed as on the dates of takeover of the proposed OTS Scheme which is in accordance with the principles and guidelines stipulated by the Commission in its earlier OTS Scheme approval order dated 20.07.2011 in Case Nos.5,6 & 7 of 2010. The representative of Department of Energy, Govt. of Odisha has stated that Govt. has supported the OTS Scheme of the DISCOMs.
- 4. After hearing the parties, the Commission opined that such OTS Scheme shall impact the revenue of GRIDCO Ltd. as per the Vesting Orders, which will ultimately pass on to the paying consumers. Therefore, the matter should be decided through public hearing. Hence, the registry of OERC is directed to provide the Public Notice to the DISCOMs to

publish the same in English language in one issue each of a daily English and Odia newspaper and in Odia language in one issue of daily Odia newspaper having wide circulation in their area of supply inviting suggestions/objections/ views from the stake holders/institutions/ organizations and general public.
