With reference to your application dated **27.11.2020** for approval of Aggregate Revenue Requirement (ARR) & Determination of Generation Tariff of OHPC power stations for the FY 2021-22, which has been registered as **Case No.70/2020**, I am directed to say that the Commission has decided to dispose of the above case through a public hearing.

2. In compliance with the provisions of Sec. 64 (2) of the Electricity Act 2003, you are required to publish the matter as attached to this letter in English language in one issue each of a daily English and Odia newspaper and in Odia language in one issue of a daily Odia newspaper having wide circulation in the State. The publication shall be made on or before **19.12.2020**. You are also required to put a copy of the said publication in the notice board of your Head Office as well as in the offices of the Unit Heads of different power stations and in your company's website.
3. You are required to arrange for facilitating inspection / perusal and prompt supply of copies of application for approval of Aggregate Revenue Requirement (ARR) and determination of Generation tariff for FY 2021-22 during office hours in the offices mentioned in Para-2 above to the interested persons.
4. A full set of the Aggregate Revenue Requirement (ARR) & Determination of Generation Tariff application as mentioned in Para (1) above can be obtained by interested persons during the office hours from **19.12.2020 to 18.01.2021** at your Head Office and offices of the Unit Heads of different power stations on payment of photocopying charges of **Rs.100/-** only.
5. It may please be noted that you may file a consolidated rejoinder before the Commission on or before **29.01.2021** with regard to all the suggestions/objections filed by the interested persons and admitted by the Commission serving a copy of the respective rejoinder to the person concerned.
6. The proof of the above publications in English and Odia dailies shall be furnished to the Commission within seven days of such publications.

Publication of Applications under Section 64(2) of the Electricity Act, 2003 for Approval of Aggregate Revenue Requirement and Determination of generation Tariff for the FY 2021-22 filed by M/s Odisha Hydro Power Corporation before the Odisha Electricity Regulatory Commission, Bhubaneswar-21.

1. M/s Odisha Hydro Power Corporation (in short OHPC), a generating company, incorporated under the Companies Act, 1956, has submitted its Application before the Odisha Electricity Regulatory Commission, Bhubaneswar on **27.11.2020** for approval of Aggregate Revenue Requirement (ARR) and Determination of generation Tariff for the FY 2021-22 in terms of Sections 64 & 86 of the Electricity Act, 2003, which has been registered as **Case No.70/2020**.
2. The Commission has decided to dispose of the matter through a Public Hearing.
3. Copies of the aforesaid filing are available at OHPC's Corporate Office, Vani Vihar Chowk, Janpath, Bhubaneswar and at the offices of the Unit Heads of its different power stations. 4. (a) Interested persons may inspect/peruse the relevant records pertaining to the matter and take note thereof at the offices mentioned above during office hours on working days on or before **18.01.2021** by making a plain paper application to any one of the aforesaid authorities. The copies of the aforesaid ARR application can be obtained from the above mentioned offices during the office hours by paying photocopy charges of Rs.100/- only.

(b) A summary of the proposal will be posted in the Commission's website after **15.01.2021** for general reference.
5. The Suggestions/objections, if any, together with supporting materials may be filed before the Secretary, Odisha Electricity Regulatory Commission, Plot No. 4, Chunokoli, Sailashree Vihar, Chandrasekharpur, Bhubaneswar-751021 in person or through Registered Post including e-mail /Courier Services only so as to reach him on or before **18.01.2021** positively. A copy of the said suggestions/objections along with relevant documents shall also be served on the undersigned.

(a) The suggestions/objections should be filed in seven copies before the Secretary, OERC and should carry full name and postal address of the person/ organizations/ institutions along with e-mail ID & Contact Telephone Number and shall be supported by an affidavit.

- (b) There shall be clear indication if the suggestions/objections are being filed on behalf of any organization/institution representing any category of consumers. It should also be specifically mentioned if it is to be heard in person by the Commission.
- (c) The date mentioned above or those which will prove deficient on any or more of the above points may not be admitted for hearing. Only those objections/suggestions supported through affidavit will be taken up for hearing.
6. The dates of hearing shall be duly published in the newspapers and also be communicated to the parties whose objections are admitted.
