ORDER

The petitioner M/s. Akuli Flyash Bricks, Mirisa, Narasinghpur, Kendrapara has come up with application under Section 142 of the Electricity Act, 2003 for non-compliance of order dated 19.08.2021 of the GRF-Paradeep passed in C.C. Case No. 709/2021. The learned GRF, Paradeep while deposing of C.C. Case No. 709/2021 has directed the respondent as follows:-

" The O.P. shall provide a correct and final estimate to the complainant considering remunerative norms basing on the revised scope and estimate framed vide their letter No.2327 dated 05.08.2021 (Rs.2,60,004.00) by strictly adhering the principles contained in Appendix-I OERC Distribution Code, 2019 and complete all process required for power supply but not exceeding 15 days from the date of this order.

The case is accordingly disposed of.

Opposite Party is directed to submit compliance report to this forum within a month of this order."

2. Heard the parties. During hearing the Executive Engineer (Elect.), KED-II, Kendrapara submitted that the petitioner had applied for new electricity connection to his fly Ash Bricks unit on 26.04.2021. After receiving the same E.E., KED-II had asked the S.D.O (Elect.), Marhaghai vide office letter No.1451 dated 04.05.2021 for submission of field survey report, single line diagram and estimate with technical feasibility report against power supply to 20KW load to the petitioner's Unit. The S.D.O (Elect.), Marshaghai vide letter No.373 dated 24.05.2021 had intimated it to the respondent. The respondent thereafter had framed an estimate amounting to Rs.4,44,048/- under 100% deposit Scheme for providing power supply to M/s. Akuli Flyash Bricks. After receiving the materials, the work has been completed as per the above order of the GRF, Paradeep passed in C.C. Case No. 709/2021. Therefore, he prays the Commission to drop this proceeding as the above order of the GRF, Paradeep has been complied by the respondent and there is no need to proceed further in the present case under Section 142 of the Electricity Act, 2003. The said fact is admitted by the authorized representative of the petitioner.

- 3. The case is dropped as both the petitioner and the respondent submit that the order dated 19.08.2021 of the GRF, Paradeep passed in C.C. Case No. 709/2021 has been complied.
- 4. With the above observation, the case is disposed of.
