**Contractual Engagement of Retired Section Officers/ Senior Assistants/ Head Clerks of Government Offices/ Public Sector Undertakings.**

Applications, in prescribed format, are invited from intending retired Section Officers/ Senior Assistants/ Head Clerks of Government Offices/ PSUs for temporary engagement of one Consultant in the office of the OERC as per the terms and conditions stipulated in the GA & PG Department Resolution No.23750/Gen., dated 27.08.2014 for a period of one year from the date of joining or till the incumbent attains the age of 65 years. The engagement shall be made with a consolidated remuneration fixed by the Finance Department in FDOM No.24533/F dated 29.9.2022.

**1. Eligibility Condition**

- (a) Retired Section Officers/ Senior Assistants/ Head Clerks of Government Offices/ PSUs Govt. Servants/PSUs who have not attained the age of 65 years are eligible.
- (b) Employees against whom departmental proceedings or criminal cases are contemplated/ pending or who have been penalised for misconduct will not be eligible for re-engagement.
- (c) The applicant for the post of Consultant must be physically fit having adequate knowledge in office establishment with sound computer knowledge.

**2. Tenure, Terms and Conditions of employment**

- (a) The above posting for the post of Consultant shall be made initially for a period of one year from the date of joining or till the incumbent attains the age of 65 years, whichever is earlier.
- (b) The retired employee shall be governed by the provisions of Odisha Govt. Servants Conduct Rules.
- (c) The retired employee can be terminated at any time for his unsatisfactory performance, by giving him one month's notice. Moreover, if the re-engaged employee desires to resigns/quits, he/she shall do so by giving one month's written notice to the Commission.
