NOTIFICATION

No. 82-OERC-ENGG-23/2001(Vol-XV)-In exercise of power conferred under Section 86 (i) of the Electricity Act, 2003 read with Regulation 10 (5) of the OERC (Conduct of Business) Regulations, 2004, the Commission on the 31st August 2009 has made a Notification fixing fees for filing of petition or application before the Commission as per the schedule of fees and that was published in the Odisha Gazette Extraordinary No. 1500, dated the 7th October, 2009. The said notification was amended once, which was published in the Odisha Gazette No. 1036, dated the 24th May 2012. Since, as per Clause 7 of the above Notification dated the 7th October, 2009, the Commission may at any time amend the prescribed Schedule of Fees without any prior notice, the Commission hereby makes the following amendments with respect to SI. No. 4 of the "Schedule of Fees" notified in the Notification dated the 24th May 2012. The Commission hereby notifies this amendment for information of general public in supersession to the earlier Gazette notification No. 1036, dated the 24th May 2012.

"Amendment to SI. No. 4 (a), (b) & (c) of Schedule of Fees"

" SI. No. 4-Annual Fee-

(a) to transmit electricity as a transmission licensee; ... Rs.1,50,00000/- (Rs. One crore fifty lakhs)

(b) to distribute electricity as a distribution licensee;

. . Rs.1,50,00000/- (Rs. One crore fifty lakhs)

(c) to undertake Bulk Supply and Trading Activity (GRIDCO) . . Rs.1,50,00000/- (Rs. One crore fifty lakhs)

(d) to undertake trading as an Intra-State per year electricity trader

Rs.1,50, 000/- (Rs. One lakh fifty thousand) for trading upto 50 MU/year; Rs.3,00, 000/-(Rs. Three lakhs) per year for trading above 50 MU upto 600 MU/year; and Rs.5,00, 000/-(Rs. Five lakhs) per year for trading above 600 MU/year.
