Sir,

With reference to your revised application on 09.01.2023 before the Commission in respect of Aggregate Revenue Requirement(ARR) and determination of Wheeling Tariff & Retail Supply Tariff for the Financial Year 2023-24 including truing up application, I am directed to say that the Commission has decided to dispose of the revised Aggregate Revenue Requirement and Determination of Wheeling Tariff & Retail Supply Tariff Application only for the FY 2023-24 through a public hearing. The Truing Up application which has been filed along with ARR and determination Wheeling Tariff and Retail Supply Tariff application shall be registered as a case separately and shall be heard accordingly. You are required to file an application to this effect immediately. Your application for Aggregate Revenue Requirement (ARR) and determination of Wheeling Tariff & Retail Supply Tariff for the Financial Year 2023-24 has been registered as Case No. 82/2022. You are directed to publish the Public Notice attached to this letter in English language in one issue each of a daily English and Odia newspaper and in Odia language in one issue of daily Odia newspaper having wide circulation in your area of supply. The publication shall be made on or before 11.01.2023. You are also required to put a copy of the said publication in the notice board of your office as well as in offices of all Engineers in charge of Distribution Divisions of your company and in your company's website.
