MOST RESPECTFULLY SHOWETH:

SLDC brings to the kind notice of the Hon'ble OERC that, the above objectors have raised objections in the matter of determination of Annual Revenue Requirement and Fees and Charges of State Load Despatch Centre (SLDC), Odisha for the FY 2026-27 along with Truing up application for FY 2023-24 & FY 2024-25. SLDC is filing one consolidated rejoinder for the objections raised by all the objectors.

Rejoinder to the objections raised by Shri Ananda Kumar Mohapatra

1. That in reply to the contents of Para-1, it is submitted that the application for determination of Annual Revenue Requirement and Fees and Charges of State Load Despatch Centre (SLDC) has been prepared in accordance with OERC (Fees & Charges of SLDC & other related matters) Regulations, 2010 and submitted before Hon'ble Commission.
2. That in reply to the contents of Para-2, it is submitted that the list of Registered Users with their particulars (such as name of the system user and point of connection along with the voltage level) is available in the home page of SLDC website for access of public in general.
3. That in reply to the contents in 5.1 it is submitted that various information as sought in this para are available in the website of SLDC for information of all stake holders.
4. That in reply to the contents in 9.1 and 9.2 it is submitted that the monthly charges of SLDC are being levied on the CGPs by SLDC in accordance with the approved fees and charges of SLDC as approved by Hon'ble commission in ARR of SLDC. Further the CGPs are also paying the intra-state transmission charges of OPTCL against Open -Access availed by them as per the applicable Regulations.
5. That in respect of the remaining points SLDC has no further submissions to offer and respectfully leaves the same for observation, analysis and ruling of the Hon'ble Commission.

Rejoinder to the objections raised by, TPWODL,TPCODL and TPSODL.

1. As per regulation 23(1) of OERC (Terms and Conditions of Intra State Open Access) Regulations, 2020 the amount of surcharge shall be paid to the distribution licensee of the area of supply from whom the consumer was availing supply before seeking open access. However SLDC has continued with the practice of serving cross subsidy surcharge bills to the open access customers as the new regulations came into effect during the time when the COVID-19 pandemic prevailed.

In light of the above submitted facts and the applicable regulations it may be clearly construed that the open access customers shall be billed/invoiced directly by the concerned distribution licensees as the same shall be collected by the licensees from their own customers .As such SLDC is providing the customer wise energy drawl schedule against open access to the distribution licensees.



2. That in respect of the remaining points raised by the DISCOMs SLDC has no further submissions to offer and respectfully leaves the same for observation, analysis and ruling of the Hon'ble Commission.

PRAYER

In view of the facts and clarifications submitted above, the accusations made by all the above objectors may not be considered by the Hon'ble Commission while approving the Annual Revenue Requirement and Fees and Charges for SLDC functions for the FY 2026-27 along with Truing up application for FY 2023-24 & FY 2024-25 (Case No. 119/2025).
