SMC Power Generation Limited and also authorized by the petitioners of the above noted cases, Shri Tapas Pattnaik, DGM (Elect.), GRIDCO Limited, Shri Subrat Kumar Mishra, DGM (Elect.), GRIDCO Limited and Ms. Sasmita Patjoshi, Manager (RE Cell) GRIDCO Limited are present.

2. All the above noted cases are taken up for hearing analogously as these are similar in nature.
3. Heard the parties at length. During hearing Shri Panda the representative of the all the above petitioners submitted that their issues with GRIDCO Ltd. have been settled as per order dated 23.11.2010 of the Commission passed in Case Nos. 117 & 118 of 2010. Therefore, these matters have now become in fructuous and the same are liable to be dismissed. The representative appearing on behalf of GRIDCO Ltd. submitted though they have constituted a Technical Committee to find out the status of a CGP as a Co-generator they do not have any issues with the petitioners. He also promised to submit the report of the committee within 15 days.
4. Since, the petitioner has stated that their grievances no longer survive after our order in Case Nos. 117 & 118 of 2010 and the respondent accept the same, the present case is dropped as dismissed.
5. The cases are accordingly disposed of.
