**ORDER**

The present application has been filed under Sec. 142 of the Electricity Act, 2003 for non-implementation of order dtd. 09.07.2010 passed in C.C. Case No. 65/2010 of GRF, Dhenkanal.

2. Sri A. K. Sahani the authorized representative appearing on behalf of the petitioner submitted that the order dated 09.07.2010 of the GRF, Dhenkanal passed in C.C. Case No. 65 of 2010, has been challenged by the respondent in the Hon'ble High Court of Orissa in WP (C) No. 22225/2010 and the Hon'ble High Court in its order dtd. 31.01.2011 has stayed operation of the order of the GRF, Dhenkanal.
3. The learned Counsel appearing on behalf of the respondent submitted that the impugned order dtd. 09.07.2010 of the GRF, Dhenkanal has been challenged in the Hon'ble High Court of Orissa by the Respondent, in the year 2010 i.e., before the present application was filed on 06.01.2011 by the petitioner u/s 142 of the Electricity Act, 2003. Mr. Nayak has also submitted the xerox copy of the interim order dtd. 31.01.2011 of the Hon'ble High Court passed in Misc. Case No. 20348 of 2010 (arising out of WP (C) No. 22225 of 2010) where in the Hon'ble High

Court has stayed the operation of the impugned order dtd. 09.07.2010 of the aforesaid GRF.

4. Heard the parties. In view of the above submission made by both the petitioner & the respondent and the order dated. 31.01.2011 passed by the Hon'ble High, the Commission do not consider to proceed further in the case at this stage.
5. Hence, the case is disposed off.
