ORDER

- 1. The present petition is filed by the petitioner for non-compliance of Commission's order dated 20.01.2011 passed in Case No.161 of 2010. The case is taken up for hearing on question of admission and hearing if it would be admitted.
- 2. Shri Misra on behalf of the petitioner submitted that the petitioner has been filed this application for non-compliance of the order dated 20.01.2011 of the Commission passed in Case no.161 of 2010 which was arising out of Case No.146 of 2009 (ARR and Fees and Charges for SLDC functions for FY2010-11. The Commission vide its order dated 20.01.2011 passed in Case No.161 of 2010 had directed as follows:-

"Lower Kolab (12MW) and Middle Kolab (25MW) Small HydroElectric Projects of Meenakshi Power Ltd., Hyderbad being the usuers of the Intrs-State Transmission network are liable to pay the System Operation Charges (MOC) and one time Registration Fee to SLDC as approved by us in ARR for SLDC for FY 2010-11".

- 3. Shri Misra also submitted that in the meanwhile the Respondent has paid all the charges except the one time Registration Fee to SLDC.
- 2. Shri Mohanty appearing on behalf of the Respondent has submitted that the Respondent has paid all charges except one time Registration Fee to SLDC and now the Respondent will also make arrangement for payment of the one time Registration Fee as early as possible. In view of the above submission the

- Respondent did not want to proceed further with the case and prayed for withdrawal of the said Case.
- 3. In view of the above submissions made by the parties and the prayer of the Respondent for withdrawal of the Case, we dismiss the case as withdrawn. We however, direct the respondent to clear the outstanding dues payable to SLDC on or before 30.06.2011 under intimation to the Commission.
- 4. Accordingly the case is disposed of.
