ORDER

The present application under S.142 of the Electricity Act, 2003 has been filed by Sri Narendra Kumar Mishra, a domestic consumer of WESCO under the Electrical Sub-Division of Sonepur for non- implementation Order of the Ombudsman-II passed on 18.09.2012 in C.R. Case No. 14/2012 by WESCO. The petitioner sought direction of the Commission to the respondents i.e. authorities of WESCO for removal of the 11kV line from the premises of the petitioner which runs much closer to his dwelling house on safety ground and to penalize the respondents for non implementation of the above orders of the Forums in time.

2. After hearing the parties on 30.07.2013, we have in our interim Order dtd. 31.07.2013 directed the respondents to implement the Order dated 18.09.2012 of the Ombudsman-II within fifteen days and submit such compliance report to this Office.

- 3. According to our above direction the respondents have filed their compliance report on 14.08.2013 regarding implementation of the Order dated 18.09.2012 of the Ombudsman-II passed in passed in C.R. Case No. Omb (II) W-14 of 2012 with due intimation of the same to the petitioner. During the present hearing respondent appeared before us and reiterated that they have already complied with the order of Ombudsman-II. Nobody was present from the side of the Petitioner. Considering the above, there is no need to initiate proceeding u/S. 142 of the Electricity Act, 2003 against the respondents as they have already complied the Order dated 18.09.2012 of the Ombudsman-II.
- 4. Accordingly the case is disposed of.
