The petitioner Smt. Premadevi Lath, wife of Shri Jagadish Prasad Lath, At- Lebdi, P.o- Bargarh, Dist.-Bargarh in the supply area of WESCO under the Executive Engineer (Elect.), Bargarh Electrical Division, WESCO, Bargarh had filed the above case u/S. 142 & 146 of the Electricity Act, 2003 for non-compliance of the order dated 06.11.2013 of the GRF, Burla passed C.C. Case No. 301 of 2013-14.

1. The case is taken up today on question of admission and hearing.
2. Heard the parties at length. The reply filed by the respondent is taken on record.
3. Shri K.C.Nanda, DGM (Fin),WESCO appearing on behalf of the respondents herein has submitted the order dated 06.11.2013 of the GRF, Burla passed in C.C.Case No. 301 of

2013-14 has been modified on the basis of the application of WESCO on 13.11.2013 and the said modified order of the GRF, Burla has been complied. As per the modification order dated 13.11.2013 of the GRF, Burla in C.C.Case No. 301 of 2013-14, a sum of Rs.1,15,350/- has already been deposited by the petitioner on 04.06.2014 in the account of the licensee-WESCO. Therefore, the issue raised in the above matter is resolved by the parties herein and the proceeding under S.142 of the Electricity Act, may be dropped.

4. After hearing the Representative appeared on behalf of the respondents and perusal of the case records we opine that though the petitioner is absent on repeated calls and there is no need to proceed in the present case as the order of the GRF, Burla passed in the said C.C.Case No. 301 of 2013-14 has been complied with the knowledge of the petitioner.
5. Accordingly the proceeding u/S. 142 & 146 of the Electricity Act, 2003 against the respondents is dropped.
