- The petitioner M/s. Hytech Pvt. Ltd. is a consumer under the Bhubaneswar Electrical Division, CESU with a contract demand of 11 KV from the year 1984 which is enhanced to 94 KW with LT supply voltage. The petitioner has filed the above case u/S. 142 of the Electricity Act, 2003 for non-implementation of the order dated 19.04.2011 of the GRF, Bhubaneswar passed in Consumer Complaint Case No.24 of 2011 (BED) regarding load reduction and revision of contract demand to 47 KW from the date of his original application dated 19.03.1998 instead of date of depositing the processing fee on 13.12.1999.
2. The case is taken up today on question of admission and hearing.
 3. Heard the parties at length. During hearing the E.E (Elect.), BED, Bhubaneswar has submitted that the respondents have already implemented the above order of the GRF, Bhubaneswar passed in Consumer Complaint Case No. 24/2011. The said submission of the respondents is also admitted by the authorized representative of the petitioner.
 4. Therefore, there is no need to proceed further in the matter u/S. 142 of the Electricity Act, 2003 against the respondents as they have already complied the said order dated 16.04.2011 of the GRF, Bhubaneswar passed in C.C. Case No.24 of 2011 (BED).
 5. Accordingly the case is disposed of.

with the following directions to the respondent which is as follows:-

- i. With complainant's CD continuing upto 31.03.1998 at 94 KW, reduce the same to 47 KW w.e.f. 01.04.1998 subject to fulfillment of other necessary conditions for the purpose.
- ii. Revised the complainant's impugned bills:
 - a. From 8/97 to 3/98 @ 56 units/KW against 94 KW
 - b. From 4/98 to 11/98 @ 56 units/KW against 46 KW C.D
 - c. From 12/98 onwards as per prevalent tariff against 47 KW
- iii. Withdraw bill amount for the disconnected month 10/98 except fixed charges
- iv. Withdraw DPS for the delayed period from 01.04.1998 onwards.
- v. (a) Withdraw meter rent, if any, for the meter-defect period pertaining to Meter No. 05E02787LTBV.

(b). Stop meter rent pertaining to Meter No. CSC09120LTCT after full recovery of the outstanding amount of Rs. 7,700/-
