## **ORDER**

The authorized representative of the petitioner Sk. Abdul Quyum & Others of Village Kasapa, Po- Ahiyas, Dist. Jajpur in the supply area of NESCO under the S.D.O (Elect.), Dasarathapur had filed the above case u/S. 142 of the Electricity Act, 2003 for non-implementation of the order dated 29.09.2013 passed by the GRF- Jajpur in C. C. Case No. 241/2011.

- 2. The case is taken up today on question of admission and hearing.
- 3. Heard the parties at length. The reply filed by the respondent is taken on record.
- 4. The S.D.O (Elect.), Dasarathapur, NESCO- the respondent herein submitted that the order

of the GRF-Jajpur passed in the above C.C.Case No. 241/2011 has been complied. The GRF- Jajpur Road directed for withdrawal of EC bill during the transformer defunct (due to burnt) period - 15.10.2005 to 10.02.2006, 10.06.2010 to 01.07.2010, 20.08.2011 to 12.12.2011 and 02.09.2012 to 25.01.2013. Out of the list furnished by the petitioner. Only eight consumer's number correctly were found in the ledger pertaining to the above period. Their bills have already been revised and reflected in billing cycle of November, 2013. Some numbers of consumers furnished were not found in the ledger. Some consumers have availed OTS offered by the Licensee. As such bills of consumers existing during transformer burning period has already been revised, excepting those who either did not exist during the event or availed OTS.

Therefore SDO, Dasarathpur prayed for dropping action u/S 142 of the Electricity Act, 2003, as the direction of GRF has been complied.

- 5. After hearing the parties and perusal of the case records we opine that there is no need to proceed in the present case as the order of the GRF-Jajpur passed in C.C.Case No. 241/2011 has been complied.
- 6. Accordingly the proceeding u/S. 142 of the Electricity Act, 2003 against the respondent is dropped.
