The petitioner Shri Rabindra Kumar Jena, At-Nahana Kulasahi, Po-Abhimanyu Balia, Dist-Jajpur is a consumer in the supply area of NESCO under the S.D.O (Elect.), Bari, NESCO had filed the above case u/S. 142 of the Electricity Act, 2003 for non-implementation of the order dated 15.03.2012 of the Ombudsman-II passed in C.R.Case No. Omb (II) N-10/2012.

2.      The case is taken up today on question of admission and hearing.
3.      Heard the parties at length. The reply filed by the respondent is taken on record.
4.      The S.D.O (Elect.), Bari, NESCO- the respondent submitted that the order of the Ombudsman-II passed in the above C.R.Case No. 10/2012 has been complied. Accordingly

Rs. 2, 87,749/- (Two lakh eighty-seven thousand seven hundred forty nine) only regarding withdrawal of the disputed bill of the petitioner has already been deducted in the bill of the month of April, 2014.

5. After hearing the parties and perusal of the case records we opine that there is no need to proceed in the present case as the order of the Ombudsman-II passed in C.R.Case No. 10/2012 has been complied.
6. Accordingly the proceeding u/S. 142 of the Electricity Act, 2003 against the respondent is dropped.
