ORDER

M/s. Newton College of +2 Science had filed the above Case u/S. 142 of the Electricity Act, 2003 for non-compliance of order dated 24.01.2013 & 04.11.2013 of the GRF, Burla in Case No. 83 of 2012-13. The GRF, Burla after careful consideration of the case and provisions under the OERC Distribution (Conditions of Supply) Code, 2004, had directed respondent herein to revise the energy bills of the petitioner as per general tariff category.

2. Being aggrieved by the common order of the GRF, Burla passed in C.C. Case Nos. 56, 58, 59, 62, 67, 83, 85 of 2012-13 M/s. WESCO Utility had filed writ petitions before the Hon'ble High Court of Orissa in WP(C) No. 4789/2014 in Case No. 83/2012-13. The above writ petition has been clubbed with the other writ petitions filed by the WESCO Utility against the above common order of the GRF, Burla passed in C.C. Case Nos. 56, 58, 59, 62, 67, 83, 85 of 2012-13.
3. After hearing the parties and going through the records along with the status report submitted by the parties, we direct the Respondent either to obtain a stay of operation of the order passed by the GRF, Burla in C.C. Case No. 83 of 2012-13 from the Hon'ble High Court or implement the said order of the GRF, Burla within 15 days

from the date of this order. However, the final outcome of the W.P.(C). No. 4789 of 2014 shall be applicable to both the parties.

4. With the above observation, the case is disposed of.
