Shri Saroj Kumar Adhikari, Nahaka Road, Jajpur has filed the above Case u/S. 142 of the Electricity Act, 2003 for non-compliance of order dated 19.12.2013 of the Appellate Authority-cum-Dy. Electrical Inspector (T&D), Jajpur Road in Case No. AAC No. 10 of 2013-14 wherein the Respondent had directed as follows:-

- "1. Final assessment order of the Assessing Officer is quashed.
- 2. Refund the amount of Rs.84,397.00 along withRs.400.00 towards reconnection charges through adjustment in the monthly bills, which has been paid by the Appellant for reconnection of his power supply."
- 2. Being aggrieved by the above order dated 19.12.2013 of the Appellate Authority-cum-Dy. Electrical Inspector (T&D), Jajpur Road in Case No. AAC No. 10 of 2013-14 M/s. NESCO Utility has filed a writ petition bearing W.P.(C). No. 19600 of 2014 before the Hon'ble High Court of Orissa. The Hon'ble Court while admitting the case has been pleased to grant interim stay of operation of the above order of the Appellate Authority passed in Case No. AAC No. 10 of 2013-14 which is continuing till date.

- 3. After going through the records and submissions made by the parties during hearing, we direct both the parties to take necessary steps for early disposal of the above writ petition pending before the Hon'ble High Court of Orissa. The final outcome of W.P.(C). No. 19600 of 2014 shall be applicable to both the parties herein.
- 4. With the above observation, the case is disposed of.
