## **ORDER**

The petitioner M/s. Hotel Smita, At/Po-Barbil, Dist-Keonjhar in the supply area of NESCO under the Executive Engineer (Elect.), JOED, NESCO, Joda Electrical Division, Keonjhar had filed the above case u/S. 142 of the Electricity Act, 2003 for non-implementation of the order dated 26.06.2013 of the GRF-Jajpur road passed in C.C.Case No. 126/2013.

- 2. The case is taken up today on question of admission and hearing.
- 3. Heard the parties at length. The reply filed by the respondent is taken on record.
- 4. The respondent Executive Engineer (Elect.), Joda Electrical Division, NESCO, Keonjhar submitted that the order of GRF was to refund the amount collected towards meter rent during 06/2004 to 11/2006 and to revise the bill for 4/2008 to 3/2010 as per RST order for 2008-09 and 2009-10 in respect of GP (HT) consumer that is flat rate of Rs. 3/- per unit. In this regard the respondent submitted that a sum of Rs. 1, 84, 504.63/- has already been

adjusted in the energy bill for the petitioner during the month of April, 2014. Further, the GRF order for installing 11 KV metering unit immediately at petitioner's unit has already been done by the respondent at petitioner's unit on 21.03.2014. Action has already been taken to return/adjust the meter rent from 06/2004 to 11/2006 amounting to Rs. 13600/with approval from higher authorities Executive Engineer (Elect.), JED submitted.

- 5. After hearing parties and perusal of case records we find that the order of the GRF in Case No. 126/2013 has been complied. Meter rent for the period from 06/2004 to 11/2006 amounting to Rs. 13600/- is in the process of adjustment leading to implementation of the order. The same should be done within two months time, if not done. Therefore, we feel, there is no need to proceed with the present case u/S. 142 against E.E.(Elect.), JED & others and should be dropped. We conclude thus.
- 6. Accordingly the case is disposed of.
