ORDER

The petitioner M/s. Bhushan Power & Steel Ltd. has filed the above case for non-compliance of the directions contained in order dated 12.05.2015 of the Commission passed in Case No. 30 of 2013 by GRIDCO Ltd.

- 2. The case is taken up today for hearing on question of admission as well as on merit.
- 3. During hearing the learned counsel appearing on behalf of M/s. Bhushan Power & Steel Ltd. has submitted that as per order dated 12.05.2015 of the Commission in Case No. 30/2013, GRIDCO Ltd has not taken steps for full and final reconciliation of outstanding dues of the CGPs like the unit of Petitioner herein. The Commission while disposing Case No. 26/2015 filed by M/s. SMC Power Generation Ltd. has observed in Para 22 as follows:-
 - "22. The issues addressed above are also applicable to similarly placed CGPs and Co-generation plants supplying their surplus power to GRIDCO Ltd. for the stated period."

GRIDCO Ltd. without reconciling the outstanding dues for supply of surplus power by the CGPs had sought the review of the order dated 29.12.2015 passed in Case No. 26 of 2015. The Commission had dismissed the review petition vide their order dated

19.07.2016. Therefore, GRIDCO Ltd. should be directed to make payment of the outstanding dues as early as possible with delayed payment surcharges.

- 4. The representative of GRIDCO Ltd. submitted that since the review petition in this regard has been dismissed by the Commission they are in the process of reconciling the outstanding dues of the CGPs, which will take one month time for completion. They prayed the Commission for allowing one month time to reconcile the dues of the Petitioner.
- 5. After hearing the parties and perusal of the case records, the Commission allow one month time as last chance to the GRIDCO Ltd. as it has given undertaking for reconciling the outstanding dues of the petitioner within one month from date of this order failing which GRIDCO Ltd. will be penalized as per Law.
- 6. With the above observation, the case is disposed of.
