The Petitioner- Fakiruddin Khan, S/o: Allauddin Khan, Binjharpur, Jajpur has filed the above noted case under Section 142 of the Electricity Act, 2003 for non-compliance of the Order dated 30.08.2011 passed by the GRF, Jajpur Road passed in C.C. Case No. 476 of 2011 and so also order dated 10.02.2012 of the Ombudsman-II passed in C.R. Case No. Omb. (II) N-61 of 2011. The GRF, Jajpur Road had disposed of the said Consumer Complaint case with the following directions:-

"To recast the billing done during the period for July,2008 to may May,2011 by taking prerecorded per month average consumption(preferably preceding to the month July,2008 consumption) into account. The Opposite Party shall however, effect power supply as per own departmental procedure by taking the clear arrear so to be arrived above into account."

- 2. During hearing the S.D.O(Electrical), Binjharpur has submitted his written reply through affidavit stating therein that they have already complied the above orders of the Forums by revising the bills of the petitioner and the same has been intimated to the petitioner.
- 3. As submitted by the Respondent the above order of the GRF, Jajpur Road passed in C.C. Case No. 476 of 2011 and confirmed by the Ombudsman-II passed in C.R. Case No. Omb (II) N-61 of 2011 has been complied by the Respondent there is no need to proceed in this matter. The Petitioner is also not present during the hearing
- 4. Accordingly the case is dismissed.
