The petitioner GRIDCO Limited has executed the revised Power Purchase Agreement (in short PPA) with M/s. Baitarani Power Project Pvt. Ltd. (in short M/s. BPPPL) on 18.12.2015 to purchase electricity from the 24 MW (3x8 MW) Lower Baitarani Small Hydro Electric Project (SHEP) developed by M/s. BPPPL in Anandapur block of Keonjhar district and has submitted the said PPA before the Commission for approval.

Earlier M/s. GRIDCO had executed a PPA with BPPPL on 10.11.2014 for the said 24 MW SHEP and submitted the same before this Commission for approval which was registered as Case No. 74/2014. During the hearing of Case No. 74/2014 M/s. BPPPL

had raised 21 nos. of disputed points in the PPA with GRIDCO. As per the interim direction of the Commission both the disputing parties sat with the Officers of the Commission and resolved nine numbers of issues in the PPA with mutual understanding. Thereafter, the Commission vide its order dated 16.10.2015 passed in Case No. 74/2014 addressed those unresolved points and directed both the parties to modify the PPA as per the observations of the Commission and submit the same to the Commission for approval. Accordingly, the present revised PPA has been submitted for approval of the Commission.

- 3. It is observed that the observations of the Commission on the disputed issues indicated in the order dated 16.10.2015 passed in Case No. 74/2014 and the issues mutually agreed between GRIDCO and M/s. BPPPL have been incorporated in the revised PPA signed between them on 18.12.2015. Therefore, no dispute survives any more.
- 4. Now, the Commission approves the revised PPA executed between GRIDCO and M/s. BPPPL for procurement of power from the 24 MW (3 x 8 MW) SHEP located at Singanali and Dargadishila village in Anandapur block of Keonjhar district of Odisha.
- 5. Accordingly, the case is disposed of.
