- Shri Jayadev Sahoo, Prop. Of M/s. Sai Stone Crusher, Golagaon, Pankapal Sasan, Jajpur has filed the above noted case u/S. 142 of the Electricity Act, 2003 for non-implementation of order dated 30.10.2015 of the GRF, Jajpur Road passed in C.C.Case No.147/2015 so also order dated 18.04.2016 of the Ombudsman-II passed in C.R.Case No. Omb (II) N-20/2016.
2. Basing on the said application, a show cause notice was issued on 25.06.2016 to the authorities of NESCO Utility for filing of reply as to why a proceeding u/S. 142 of the Electricity Act, 2003 will not be initiated for non-compliance of the above orders passed by the aforesaid forums. In reply to the said cause, the Respondent has submitted that NESCO Utility have already implemented the above orders of the GRF, Jajpur Road so also order of the Ombudsman-II passed in C.R.Case No. Omb (II) N-20/2016 vide their office order No. 4357 dated 05.07.2016 by sanctioning of an amount of Rs. 34, 121.00 (Rupees thirty four thousand twenty-one) only towards refund security deposit along with accrued interest thereon as per order of the above Fora. The said amount of Rs. 34121.00 bearing Cheque No. 173982 dated 05.07.2016 issued in favour of Shri Jayadev Sahoo, Prop. M/s. Sai Stone Crusher which includes Rs. 1091.00 (Rupees one thousand ninety-one) only as interest amount has been sent through registered post with due acknowledgement.
3. After perusal of the case records in hand, we opine that as the said orders of the GRF, Jajpur Road dated 30.10.2015 passed in C.C.Case No. 147 of 2015 so also order dated 08.04.2016 of the Ombudsman-II passed in C.R.Case No. 20 of 2016 have been already complied by the respondent and an amount of Rs. 34121.00 towards security deposit along with interest thereon has been sent through Registered Post to the petitioner. The Petitioner has not responded to our Show Cause Notice thereby indicating that his grievances no more survive. Therefore, there is no need to proceed further in this matter and accordingly, the case is dropped.
