## **ORDER**

GRIDCO Ltd. has filed this case for approval of the Power Purchase Agreement (PPA) executed with M/s. KRATOS Transmission & Infrastructure Pvt. Ltd. for procurement of the entire power sent out from their proposed 6 MW Biomass power plant at Dabugaon in the district of Nawarangapur towards fulfilling its specified Renewable Purchase Obligation. The PPA was signed by the Developer- M/s. KRATOS Transmission & Infrastructure Pvt. Ltd. with GRIDCO Ltd. as per order dated 15.01.2014 of the Commission passed in Suo Motu Proceeding Case No. 80/2013 for the renewable energy projects for FY 2013-14 to 2015-16.

- 2. The case is taken up today for hearing with due notice to the parties concerned. The Respondent M/s. KRATOS Transmission and Infrastructure Pvt. Ltd. was absent during hearing of the matter on 02.05.2017, 11.07.2017 and also in the hearing today i.e. on 05.06.2018 on repeated calls. It shows that the developer M/s. KRATOS Transmission & Infrastructure Pvt. Ltd. is not serious for execution of their project for which GRIDCO is facing difficulties to meet the RPO target in schedule time. Therefore, GRIDCO Ltd. prayed for withdrawal of the present petition in the above case as it has become infructuous.
- 3. The prayer is allowed. Accordingly, the present case is dismissed as withdrawn by the Petitioner.
