## **ORDER**

Shri Ananta Charan Bhuyan of Kalakhand, Jajpur has filed the above case u/S. 142 of the Electricity Act, 2003 for non-compliance of order dated 02.08.2014 of GRF, Jajpur Road passed in C.C. Case No. 114 of 2014 and order dated 07.06.2016 of the Ombudsman-II passed in C.R. Case No. Omb (II) N-28 of 2016 and also order dated 08.12.2016 of the said Forum passed in C.R. Case No. Omb (II) N-50 of 2016.

2. The representative of the petitioner has submitted that the fact of the case is relating to non-compliance of order of Ombudsman-II. The Ombudsman-II passed an order on 07.06.2016 which inter-alia contains a direction to NESCO Utility to give opportunity of hearing to the Petitioner before issuing final assessment order under Section 126 which was made during meter defective period. When this order of Ombudsman-II was not complied the Petitioner again moved the Ombudsman-II who in his order dated 08.12.2016 after hearing both the parties directed that the Petitioner should be given an opportunity for hearing within 15 days and the compliance be filed with the

Ombudsman within 30 days. As the above order of the Ombudsman-II passed in Case No. 50/2016 was not complied by the respondent, the petitioner moved the Commission for implementation of the said order of the Ombudsman-II in the aforesaid C.R. Case No. Omb (II) N-50/2016.

- 3. The SDO (Elect.), Bari submitted that he has joined recently in the above sub-division of NESCO Utility and prayed for some time to implement the above order of the Ombudsman-II passed in C.R. Case No. Omb (II) N-50/2016.
- 4. Prayer of the respondent is allowed. The respondent is directed to comply the above order dated 08.12.2016 of the Ombudsman-II passed in C.R. Case No. Omb (II) N-50/2016 within 15 days from today with intimation to the Commission.
- 6. Accordingly, the case is disposed of.
