The present Petitioner Shri Umesh Chandra Dora has filed this application under Section 142 of the Electricity Act, 2003 for non-implementation of Order dated 01.12.2016 of the Appellate Authority-cum-Dy. Electrical Inspector, Jajpur Road, Jajpur passed in Case No. AAC No. 02 of 2015 wherein the Appellate Authority-cum-Dy. Electrical Inspector, Jajpur Road, Jajpur has set-aside the final assessment order of the Assessing Officer passed under S.126 of the Electricity Act, 2003 and has directed the respondent to refund the 50% of the final assessment amount i.e. Rs.29,254/- deposited by the petitioner-consumer with the Distribution Utility through adjustment in the monthly bills and allow him as a single phase domestic consumer considering the load to be within 5KW and also revise the bills as per domestic tariff.

2. During hearing the authorized representative of the petitioner submitted that as the above order of the Appellate Authority-cum-Dy. Electrical Inspector, Jajpur Road, Jajpur passed in Case No. AAC No.02 of 2015 had not been complied by the respondent, the petitioner filed the above case before this Commission u/Sec. 142 of the Electricity Act, 2003. The representative of the petitioner further submitted that after the petitioner filed the above case u/Sec. 142 of the Electricity Act, 2003 before the Commission the respondent has implemented the aforesaid order of Appellate Authority-cum-Dy. Electrical Inspector, Jajpur

Road. Therefore, there is no need to proceed further in this matter and the case may be dropped.

3. After hearing the representative of the petitioner and basing on the submissions made during hearing, the present proceeding is dropped as the order of the Appellate Authority-cum-Dy. Electrical Inspector, Jajpur Road, Jajpur passed in Case No. AAC No. 02 of 2015 has been complied by the Respondent.
4. The case is disposed of accordingly.
