The present petition has been filed by M/s. Baitarani Power Project Pvt. Ltd. under Sections 86 of the Electricity Act, 2003 relating to confirmation regarding tariff applicable in respect of Renewable Energy Power Projects including small hydro projects for the third control period commencing from FY 2018-19.

2. The case is taken up for hearing. During the hearing the representative of the petitioner submitted that they have filed an application under Section 94 (1) (f) read with Regulation 70 of OERC (Conduct of Business) Regulations, 2004 for review of order dated 16.02.2019 passed in Case No. 46/2018 as there is no specific tariff fixed by the Commission for M/s. Baitarani Power Project Limited. The said application for review contains all the issues raised in this case regarding determination of tariff of SHEP. Therefore, he prayed for withdrawal of the present case.
3. The representative of GRIDCO submitted that during hearing on 26.06.2018 GRIDCO has prayed for tagging the present matter along with the suo motu proceeding in Case No. 46/2018 for determination of tariff of RE Sources for the control period from 2017-18 to 2019-20. The order passed in the said suo motu

proceeding initiated by the Commission is applicable to M/s. Baitarani Power Project Pvt. Ltd. though there is no specific tariff mentioned for the above project.

4. The prayer of the petitioner for withdrawal of the above case is allowed. Accordingly, the case is dismissed as withdrawn.
