One Sri Daitary Sahoo has filed the above case under section 142 of the Electricity Act, 2003 for non-implementation of order dated 15.2.2019 of the GRF, Paradeep passed in C.C. Case No.06 of 2019. The GRF, Paradeep while disposing of the above consumer complaint Case No. 6/2019 had directed the respondent to revise the bills of the petitioner from 9/1998 to 4/1999, 01/2002 to11/2003 & 01/2016 to 06/2018 as per the revised statement filed in the GRF. It was further directed that load factor bills should be revised from 09/2001 to 10/2001@36 units per month. After adjustment of Rs.6,000/- towards final assessment amount, the rest amount out of penalty of Rs.40,300/- needed to be withdrawn. The revision should be reflected in the next month billing.

2. The case was taken up for hearing. Nobody was present on behalf of the Petitioner. During hearing the Respondent-SDO (Elect.), Marshaghai, Kendrapara submitted that as per order of the GRF, Paradeep passed in C.C. Case No. 06/2019, the bills of the petitioner/consumer had been revised and an amount of Rs.34,300/- credited in the bill for the month of April, 2019. Rest of the order of GRF had been complied. The penal bill of Rs.40,300/- had also been withdrawn.

- 3. After hearing the respondent and perusal of the case records, we opine that the order dated 15.02.2019 of the GRF, Paradeep passed in C.C. Case No. 06 of 2019 has been complied by the respondent. Therefore, there is no need to proceed further in the above matter.
- 4. The case is closed.
