## **ORDER**

Due to Covid pandemic situation the Commission had decided to hear the matter through Video Conferencing in the Virtual Court on 19.01.2021. Accordingly the parties had been intimated.

- 2. M/s. Subhalaxmi Grain Processing (P) Ltd., Banpur Khurda has filed the above case under section 142 of the Electricity Act,2003 for non-implementation of order dated 20. 09.2018 of the GRF, Bhubaneswar at Khurda passed in C.C.Case No.634 of 2018. The learned GRF, Bhubaneswar at Khurda while disposing of C.C.Case No.634 of 2018 has directed the respondents to reduce the load from 110KVA to 50 KVA with effect from 01.04.2016 subject to deposit of processing fee along with other relevant documents as per the norms of OERC( Conditions of Supply) Code,2004 and also to provide reconnection as per norms on receipt of RCF.
- 3. The case is taken up today for hearing through video conferencing. On repeated calls neither the petitioner nor respondents or their authorized representative did not appear. The respondents in their reply submitted that being aggrieved by the said order of the GRF, Bhubaneswar at Khurda passed in C.C.Case No.634 of 2018, have challenged the same before the Hon'ble High Court of Orissa in W.P.(C) No.12675 of 2019 and the Hon'ble

Court has been pleased to stay the operation of the above order of the GRF-Bhubaneswar. The said interim order of the Hon'ble Court is still now continuing.

- 4. After perusal of the case records, the Commission opines that there is no need to proceed further in the present case as the order of the GRF, Bhubaneswar at Khurda passed in C.C.Case No.634 of 2018 has been stayed by the Hon'ble High Court in W.P.(C) No.12675 of 2019. The order to be passed by the Hon'ble Court in the above writ petition shall be binding on the parties herein.
- 5. With the above observation the case is disposed of.
