M/s. Sagarika Bricks, Kurangasasan, Cuttack has filed the above case under Section 142 of the Electricity Act,2003 for non-implementation of order dated 13.03.2020 of the Ombudsman-I passed in C.R.Case No.07 of 2020 impleading the Executive Engineer (Elect.), CED, Jobra, CESU, Cuttack. The Ombudsman-I while disposing of C.R.Case No.07 of 2020 has directed the petitioner to erect the D.P. structure for installation of H.T. metering unit and intimate the Opposite party (Respondent herein) within 10 days of the said order. The opposite party was directed to install and commission the H.T. Metering system within 15 days of erection of D.P. structure by the petitioner failing which the petitioner shall be billed on LT tariff without inclusion of transformer loss units after 15 days.

2. As per the above order of the Ombudsman-I, the petitioner after erection of D.P. structure for installation of H.T. metering unit has intimated the same to the respondent on 12.03.2020 for installation of the H.T. meter as early as possible.

3. The Commission decided to hear the matter on 14.07.2020 through Video Conferencing in the Virtual Court and accordingly notice dated 07.07.2020 was issued to the parties concerned. Respondent has submitted through video conferencing that they have complied the order dated 13.03.2020 of the Ombudsman-I passed in C.R. Case No.07 of 2020. The representative of petitioner present during the hearing agreed to the same.
4. As the order of the Ombudsman-I dated 13.03.2020 passed in C.R. Case No.07 of 2020 has already been complied by the respondent there is no need to proceed further in the above matter.
5. With the above observation the case is disposed of.
