Sri Narayan Mishra, S/O. Late Braja Mohan Mishra, At-Piteipur, P.O:Kantapari, Dist.-Bhadrak-756117 has filed this petition under Sections 142&146 of the Electricity Act,2003 for non-compliance of order dated 23.03.2017 of the GRF, Balasore passed in C.C. Case No.39 of 2017.

- Due to Covid-19 pandemic situation, the Commission had decided to hear the matter through Video Conferencing in the Virtual Court on 22.06.2021. Accordingly the parties had been intimated.
- 3. The application of Sri Narayan Mishra, S/O. Late Braja Mohan Mishra, At-Piteipur, Po-Kantapari, Bhadrak was taken up for hearing. The authorized representative of the petitioner submits that the above case under Sections 142 and 146 of the Electricity Act, 2003 was filed due to non-compliance of the order dated 23.03.2017 of the GRF, Balasore passed in C.C. Case No.39 of 2017. The GRF, Balasore while disposing of the case had directed the Opp. Party-respondent herein to recast the energy bills from November,2000 as per actual meter reading by considering the final meter reading of 14501KWH of meter bearing Sl. NS37453 as specified in the verification report

- bearing Sl.15582 dated 21.03.2017. The Respondent is directed to implement the order in letter and spirit within thirty days from date of receipt of this order.
- 4. The S.D.O(Elect.), Dhamanagar Electrical Sub-Division, TPNODL, Dhamanagar, Bhadrak submits that the respondent has complied the said order dated 23.03.2017 of the GRF, Balasore passed in C.C. Case No. 39 of 2017 in letter and spirit. The compliance report has intimated to the consumer and the consumer has also agreed to the same. Therefore, he has prayed the Commission to drop the proceeding initiated under Sections 142 and 146 of the Electricity Act, 2003 as the order dated 23.03.2017 of the GRF, Balasore passed in C.C. Case No.39 of 2017 has been complied. The authorized representative of the petitioner submits that the respondent be directed to serve the revised statements to the petitioner.
- 5. The case is dropped as the order dated 23.03.2017 of the GRF, Balasore passed in C.C. Case No. 39 of 2017 has been complied. The respondent is directed to serve the copy of the revised statement of the bills to the petitioner within seven days from the receipt of this order.
