M/s. S.K. Food Products, Plot No.245, Sector-A, Zone-B, Mancheswar Industrial Estate, Bhubaneswar-751010 has filed this application petition under Section 142 of the Electricity Act,2003 due to non-compliance of order dated 15.01.2020 of the GRF, Bhubaneswar passed in C.C. Case No.865 of 2019.

- Due to Covid-19 pandemic situation, the Commission had decided to hear the matter through Video Conferencing in the Virtual Court on 22.06.2021. Accordingly the parties had been intimated.
- 3. The application of M/s. S. K. Food Products, Plot No.245, Sector-A, Zone-B, Mancheswar Industrial Estate, Bhubaneswar was taken up for hearing. The authorized representative of the petitioner submits that the above case under Section 142 of the Electricity Act, 2003 was filed due to non-implementation of the order dated 15.01.2020 of the GRF, Bhubaneswar passed in C.C. Case No. 865 of 2019. The GRF, Bhubaneswar while disposing of the case had directed the respondent to revise

the additional security deposit calculation for the enhancement of load from 38KW to 151KVA and to refund the excess security deposit received to that effect by way of adjustment in the subsequent monthly energy bills by intimating the same to the petitioner.

- 4. The E.E (Elect.), TPCODL, BED, Bhubaneswar submits that the respondent has complied the order dated 15.01.2020 of the GRF, Bhubaneswar passed in C.C. Case No. 865 of 2019 in letter and spirit. The compliance report has been intimated to the consumer. The consumer has also agreed to the same. Therefore, he has prayed the Commission to drop the proceeding initiated under Section 142 of the Electricity Act, 2003 as the order of the GRF, Bhubaneswar has been complied.
- 5. The respondent says that he has complied the order dated 15.01.2020 of the GRF, Bhubaneswar passed in C.C. Case No.865 of 2019 in letter and spirit and the petitioner has admitted the same. The petitioner has also prayed to drop the present proceeding under Section 142 of the Electricity Act, 2003. Therefore, we are of the view that there is no need to proceed further in this matter.
- 6. Accordingly, the case is dropped as order dated 15.01.2020 of the GRF, Bhubaneswar passed in C.C. Case No.865 of 2019 has been complied.
