## **ORDER**

The present Petitioner M/s. Delight Layer Pvt. Ltd., Nua Babanpur, Aska, Ganjam has filed this application under Section 142 of the Electricity Act, 2003 for non-compliance of order dated 26.02.2021 of the GRF, Berhampur passed in C.C. Case No.96 of 2020.

2. The Authorized representative of the petitioner submits that the above case under Section 142 of the Electricity Act, 2003 was filed for non-compliance of the order dated 26.02.2021 of the GRF, Berhampur passed in C.C. Case No.96 of 2020. The GRF, Berhampur while disposing of C.C. Case No. 96 of 2020 had directed the respondent to withdraw the transformer loss charged from 08/2019 onwards and to verify the MMFC already charged as per the tariff order. The petitioner was also directed to pay the revised bill within 15 days of receipt of the revised bill from the

respondent, failing which the respondent had got liberty to disconnect the power supply for non-payment of the dues.

- 3. The Executive Engineer (Electrical), AED-1- the Respondent herein submits that he has complied the said order dated 26.02.2021 of the GRF, Berhampur passed in C.C. Case No.96 of 2020 in letter and spirit. As per the Order of the GRF, Berhampur the respondent has withdrawn transformer loss of Rs.6,023/- for the period for September, 2019 to February, 2020 in the energy bill for the month of March, 2021. The energy bills of the petitioner regarding MMFC charge have been revised, an amount of Rs.42414/- has been withdrawn and the same will be effected in the energy bill for the month of August, 2021. Therefore, he has prayed the Commission to drop the proceeding initiated under Section 142 of the Electricity Act, 2003 as the order of the GRF, Berhampur passed in C.C. Case No.96 of 2020 has been complied.
- 4. The authorized representative of the petitioner agrees to the contention of the Respondent that he has complied the order dated 26.02.2021 of the GRF, Berhampur passed in C.C. Case No.96 of 2020 in letter and spirit and prays the Commission to drop the present proceeding initiated under Section 142 of the Electricity Act, 2003. We are of the view that there is no need to proceed further in this matter as the order of GRF, Berhampur passed in C.C. Case No.96 of 2020 has been complied by the Respondent.
- 5. Accordingly, the proceeding under Section 142 of Electricity Act, 2003 is dropped as the order dated 26.02.2021 of the GRF, Berhampur passed in C.C. Case No.96 of 2020has been complied.
- 6. Accordingly, the case is disposed of.
