**ORDER**

The petitioners Shri Pawan Kumar Agarwal and Sri Jadumani Giri have come up with a common application under Section 142 of the Electricity Act, 2003 for compliance of order dated 30.03.2021 of the Ombudsman-II passed in C.R. Case No. 12 of 2021. The learned Ombudsman-II while disposing of C.R. Case No. 12/2021 has directed the respondent as follows:-

*“In view of the above facts and circumstances and after examining the records submitted by both the parties, this Authority pronounces the following orders:*

- 1. The respondent is directed to raise bills on Monthly Minimum Fixed Charges/Demand Charges till termination of initial period of agreement i.e. 11.10.2006.*
- 2. The respondent is directed to calculate the security deposit as per regulation 21 & 22 of OERC Code 2004 and to adjust the same in the final outstanding bill of the petitioners.*
- 3. The respondent is directed to claim DPS as per Regulations and Tariff orders from time to time till termination of initial period of agreement i.e. 11.10.2006.*

*The respondent is directed to act as per the above directions and serve the revised to the petitioner within 15 days from the date of receipt of letter of acceptance from the petitioner and file compliance within 30 days before this Authority.*

*The Case is disposed of & closed.”*

2. During hearing the Authorized representative of the petitioners submitted that the order dated 30.03.2021 of the Ombudsman-II passed in C.R. Case No. 12/2021 has been complied by the respondent. The power supply has been given to the petitioner after following the statutory provisions of the Supply Code. Therefore, he prayed the Commission to drop this proceeding as the above order dated 30.03.2021 of the Ombudsman-II passed in C.R. Case No. 12/2021 has been complied by the respondent and there is no need to proceed further in the present case under Section 142 of the Electricity Act, 2003.
3. Heard the parties at length. The case is dropped, since the order dated 30.03.2021 of the Ombudsman-II passed in C.R. Case No. 12 of 2021 has been complied by the respondent.
4. With the above observation, the case is disposed of.
