ORDER

The petitioner Mrs. Sachin Sharma, wife of Shri Sri Sudhir Sharma of Gayal Banka, Cuttack has come up with an application under Section 142 of the Electricity Act, 2003 for non-compliance of order dated 10.06.2022 of the GRF, Khurdha passed in C.C. Case No.89/2022 by the S.D.O(Elect.),TPCODL. The learned GRF, Khurdha while disposing of the case of above consumer complaint has directed the respondent as follows:-

- "1. The Respondent is directed to consider the meter reading as on 06.04.2021 as land the meter reading as on 09.08.2022 as 10768 split the units & revise the bills.
- 2. The Respondent is directed to revise the average bills from 01.06.2020 to 05.04.2021 as per the arrived average from the consumption of meter at 1 above.
- 3. In the interim period till bill revision, the Respondent is directed to reconnect the power supply subject to payment of Rs.30,000/- along with RCF provisionally and the Petitioner is allowed to pay the current dues till the bill revision is not done by the Respondent."

- 2. The authorized representative of the petitioner has submitted that as the above order of the GRF, Khurdha passed in C.C. Case No.89/2022 has not been complied by the Respondent, the petitioner herein has filed the present case for implementation of the above order of the GRF, Khurdha.
- 3. The respondent-S.D.O(Elect.), TPCODL has submitted that in obedience to the above order of the GRF, Khurdha at serial 1 & 2, electricity bills against Consumer No.05323013 in the name of Shri Sachin Sharma has been revised and as a result of the revision, an amount of Rs.30,236.71/- has been deducted from the bill of the Petitioner. The Respondent further submits that with regard to the direction of the Learned GRF, Khurdha at serial 3, electricity supply to the consumer-petitioner has been restored after payment of Rs.30,000/- and RCF of Rs.472/- by the petitioner-consumer. Therefore, the Respondent has prayed the Commission to drop the proceedings initiated under Section 142 of the Electricity Act, 2003 as the order passed by the GRF, Khurdha in C.C. Case No. 89 of 2022 has already been complied.
- 4. During hearing, the authorized representative of the Petitioner has not agreed with the compliance report submitted by the Respondent against the order passed by the GRF, Khurdha passed in C.C. Case No. 89/2022 as the compliance is not upto the satisfaction of the petitioner.
- 5. Heard the representative of the Petitioner and the Respondent at length through virtual mode. Since the Petitioner is not satisfied with the Respondent in so far as compliance of the order of the GRF, Khurdha passed in C.C. Case No. 89/2022, the matter is remanded to GRF, Khurdha to verify as to whether their order has been complied in letter and spirit or not. The GRF, Khurdha is directed to take up the matter for hearing on 26.12.2022 to ascertain the status of implementation of their order with due notice to the parties concerned and shall submit their findings after hearing both the parties. The Petitioner is at liberty to approach this forum, if GRF, Khurdha finds that their order has not been complied with.
- 6. With the above directions to the parties, the case is disposed of. The Registry is directed to send a copy of this order to GRF, Khurdha along with the copy of the petition.
