The Petitioner- M/s. Auroshree Stone Crusher, Dadhimachhagadia, P.O: Kaipadar, Dist.-Khordha has filed the present petition under Section 142 of the Electricity Act, 2003 for non-compliance of order dated 20.02.2021 of the GRF, Bhubaneswar at Khordha passed in C.C.Case No.650 of 2020.

2. The Representative of the petitioner submits that the Petitioner is a consumer under the jurisdiction of the Respondent bearing Consumer No.90036847/CA No.80000254567 with a contract demand of 105.55KVA at 11KV supply. The Petitioner availed power supply by depositing an amount of Rs11,36,286.00 towards security deposit vide Money Receipt No.214708/BV dated 01.08.2018 on load 200 KW/222.22KVA at 11KV end executing an Agreement dated 11.09.2018 for the purpose of Stone Crusher Unit. Under Large Industrial Tariff category. The Unit of the Petitioner was made power supply on 15.10. 2018. Thereafter, the Petitioner has applied for reduction of its contract demand from 200KW/222.22KVA to 95 KW/105.55KVA on 30.03.2019 by depositing Rs.1000/- vide Money Receipt No.380293/CE dated 27.04.2019. Accordingly, the MD was verified from Dec<2019 to April, 2020 and the Contract

demand has reduced from 200KW/222.22KVA to 95KW/105.55KVA on 1.12. 2019. Thereafter, the Petitioner has executed for above contract demand with the Respondent on 22.06.2020 and approached the Respondent for revision of the same. But due to inaction of the Respondent, the petitioner moved to the GRF, Khordha for redressal of its grievance in C.C.Case No.650 of 2020.

- 3. The Learned GRF, Khordha while disposing of the above C.C.Case No.650 of 2020 has directed the Respondent as follows:
 - " 1. To revise the bills from March, 2019 to June, 2020 as per the new meter consumption pattern taking the average of six months.
 - 2. Torefund security depositif any after review of the financial year consumptuion as per Clause 53 & 54 of the OERC Distribution (Conditions of Supply) Code, 2019 immediately.
 - 3.To extend TOD benefit to the consumer for the past period on availability of dump report.
 - 4. To reduce the Contract demand from 222.22KVA to 105.55 KVA w.e.f.01.05.2019."
- 4. The Commission vide their Interim Order dated 04.04.2023 has observed that the licensee has complied the order of the GRF, Khordha at Bhubaneswar in part and the rest part is undertaken to be complied with by it within a period of one month.
- 5. The Representative of the Respondent has submitted that the bill revision is made as per the direction of the GRF, Khordha passed in C.C.Case No.650 of 2020 and an amount of Rs.41,70,941/- including Rs.41,28,237/- for the then CESU period and Rs.42,704/- for TPCODL is approved GRIDCO Committee members and Headquater
- 6. With the above observations and direction, the Case is disposed of.
