## **ORDER**

The Petitioner-Sri Amarendra Sahoo, S/o. Late Kailash Chandra Sahoo of Khosalipur, Chandikhol, Jajpur has filed the present petition under Section 142 of the Electricity Act, 2003 alleging non-implementation of order dated 13.08.2021 of the GRF, Jajpur Road passed in C. C. Case No.25 of 2021.

2. The learned GRF, Jajpur Road while disposing of the C. C. Case No.25 of 2021 had directed the Respondent-Licensee as follows:

"Having heard both the parties, having perused the documents and after careful consideration of the case, the Members of the Forum direct the Respondent to convert the supply category from "COM" to "DOM" since September, 2016 and issue a revised bill to the Complainant.

Accordingly, the case is disposed of.

The Opposite Party is directed to submit the compliance report to this Forum within a month from the date of issue of this order."

- 3. As the above order of the Learned GRF was not complied with by the Respondent-Licensee, the Petitioner has moved the Commission alleging non-implementation of the said order of the GRF passed in C. C. Case No.25 of 2021 by filling the present case.
- 4. Heard the Parties. In course of hearing, the Respondent-the Deputy Manager (Electrical), Dharmasala Electrical Sub-Division, TPNODL herein submits that as per the order of the Learned GRF, Jajpur Road passed in C.C. Case No.25 of 2021, the Respondent has taken steps for implementation of the same. According to the direction of the Learned GRF,

Jajpur Road, the Respondent-Licensee has converted the supply category from "COM" to "DOM" of the Consumer-Petitioner from September, 2016 and as per billing statement, an amount of Rs.55,572.67/- has been withdrawn (after approval of their Corporate Office, Balasore) from the EC of the Consumer-Petitioner in the month of November, 2023. The copy of the said revised of bill has also been served to the Consumer-Petitioner vide TO Letter No.581 dated 16.11.2023. Therefore, the Commission has been requested by the Licensee to drop the present proceeding initiated under Section 142 of the Electricity Act, 2003 as the order of the Learned GRF, Jajpur Road has already been complied in letter and spirit. The Authorized Representative of the Petitioner does not dispute the above submissions made by the Respondent-Licensee.

- 5. Considering the above submissions of the parties, the Commission finds that there is no need to proceed further in present case and accordingly, the case is dropped as the order dated 13.08.2021 of the GRF, Jajpur Road passed in C. C. Case No.25 of 2021 has already been complied with.
- 6. The case is disposed of accordingly.
