This matter is taken up for hearing through hybrid arrangement. Shri A.K.Sahani, the Authorized Representative of the Petitioner and Sri Amaresh Chandra Bal, Dy. Manager (Legal), TPWODL on behalf of the Respondent do appear.

- 2. The Petitioner had filed the present petition under Section 142 of the Electricity Act, 2003 alleging non-compliance of the order dated 27.06.2023 of the Learned Ombudsman-II passed in C.R. Case No.09 of 2023. The Learned Ombudsman-II while disposing of C.R. Case No.09 of 2023, has issued the following directions:
 - "1) The Respondent is directed to refund the cost of PT deposited by the Petitioner.
 - 2) The Respondent is directed to refund Rs.4,45,456.91 against excess security deposit amount through adjustment in the subsequent monthly energy bills of the Petitioner.
 - 3) The Respondent is directed to take adequate steps for eradication of interruption in the power supply system providing power supply to the Petitioner."
- 2. The Commission, vide their interim order dated 14.05.2024, had allowed time to the Respondent-Licensee in view of difficulties expressed for implementation of the above direction of the Learned Ombudsman-II and had directed the Respondent-Licensee to implement the aforesaid order of the Learned Ombudsman-II in letter and spirit at the earliest.

- 3. In course of hearing, the Representative of the Respondent-Licensee submits that the aforesaid order dated 27.06.2023 of the Learned Ombudsman-II passed in C.R. Case No.09 of 2023 has already been complied in letter & spirit and prays before the Commission for closing the present proceeding. The Authorised Representative of the Petitioner also submits no objection for closing of the case.
- 4. Accordingly, the Petition stands dropped & closed.
