

**ODISHA ELECTRICITY REGULATORY COMMISSION

This matter is taken up today for hearing through hybrid arrangement (virtual/physical mode).

- 2 The present petition has been filed by the Petitioner for implementation of order dated 31.10.2022 passed by the learned GRF, Jajpur Road in C.C. Case No.93 of 2022 wherein the learned GRF has directed as follows:-

“ The bill so claimed on the units consumed prior to May, 2022 is allowed to remain as it is.

A revised bill may be served to the petitioner.”

- 3 As the above order of the GRF, Jajpur Road was not complied by the present Respondent, the Petitioner moved to the Ombudsman-II vide C.R. Case No.70 of 2022 for implementation of the said order of the GRF. The learned Ombudsman-II after heard the parties has directed the Respondent to implement the aforesaid order of the GRF, Jajpur Road passed in C.C. Case No.93 of 2022 within 15 days from the date of order i.e. from 13.02.2023 and file the compliance of the above within 30 days before this Authority.
- 4 Being aggrieved by the above order of the Ombudsman-II as well as the order of the GRF, Jajpur Road passed in C.C. Case No.93 of 2022, The Respondent herein has filed W.P.(C) No.13656 of 2023 before the Hon'ble High Court of Orissa. by the Hon'ble High Court of Orissa passed in WP(C) No.13656 of 2023.
- 5 Shri Sukanta Kumar Jena, Junior Manager(Legal), TPNODL-the representative of the Respondent-TPNODL submitted that the Respondent has withdrawn WP(C) No.13656 of 2023 filed by them before the Hon'ble High Court and revised the bill of the Petitioner as per direction of the learned GRF, Jajpur Road passed in C.C. Case No.93 of 2022. The Petitioner is also satisfied with the revision of his bill and full arrear amount has been made payment by him. Therefore, there is no need to proceed further in the present matter as the order of the GRF, Jajpur Road has been complied in letter and spirit.
- 6 Considering the submission of the Respondent, we closed the present proceeding with a direction to the Respondent to submit the compliance report of such implementation of the order of the GRF, Jajpur Road passed in C.C. Case No.93 of 2022 to this Office with copy to the Petitioner.
- 7 Accordingly, the case is disposed of.
