The Petitioner- M/s. Shree Guru Bricks., Managovindapur, Jajpur has filed the present petition under Section 142 of the Electricity Act, 2003 alleging non-implementation of order dated 15.04.2021 of the GRF, Jajpur Road passed in C.C. Case No.20/2021 as well as order dated 19.08.2021 of the Ombudsman-II passed in C.R. Case No.36 of 2021.

- 2. The Learned Ombudsman-II while disposing of C.R. Case No.36 of 2021 has observed as follows:
 - "x xx it is observed that the Respondent has taken steps for implementation of aforesaid order of the GRF, Jajpur Road by way of seeking necessary instruction from his higher authorities. But till date he has not received any communication from his higher Authorities regarding implementation of the above order of the learned GRF. As this case is filed before this Authority by the Petitioner for implementation of the above order dated 15.04. 2021 in Case No.20/2021 of the learned GRF, Jajpur Road, this Authority is of opinion to direct the Respondent to implement the aforesaid order of the learned GRF, within 30 days from the date of this order."
- 3. We heard the Parties. In course of hearing, the Executive Engineer(Electrical), JRED-the Respondent herein submits that the order of the Learned Ombudsman-II passed in C.R. Case No.36 of 2021 has already been implemented and the revision has also made as per order of the GRF, Jajpur Road and copy of the said revision of bill is to be served

on the Petitioner in the ensuing electricity bill. The Authorized Representative of the Petitioner has agreed to the above submissions of the Respondent and prays the Commission to direct the Respondent to serve a copy thereof in respect of such revision of the bills of the Petitioner.

- 4. Upon hearing the above submissions of the parties, the Commission finds that there is no need to proceed further in present case and accordingly, the Respondent-TPNODL is directed to serve the compliance report on the Petitioner with an intimation to this Commission.
- 5. With the above direction to the Respondent-TPNODL, the case is disposed of.
