Case No.117 of 2023 after receipt of the necessary NOC by the Licensee from the office of GRIDCO. The Authorized Representative of the Petitioner

agrees to the above submissions of the Respondent and does not object to drop the present proceeding.

Considering the above submissions of the Respondent-Licensee and the Authorized Representative of the Petitioner, the Commission finds that there is no need to proceed further in the present case and accordingly the Respondent-TPCODL is directed to comply with order of the Learned GRF, Cuttack passed in C.C. Case No.117 of 2023 within a month and submit a compliance report to the Commission.
- 5. With the above direction to the Respondent-Licensee, the case is disposed of.
