This matter has been taken up for hearing through hybrid arrangement.

- The Petitioner- M/s. Sai Shymala Fuel Station, Kholliguda, Rayagada, Koraput has filed the
 instant petition under Section 142 read with Section 146 of the Electricity Act, 2003 for noncompliance of the order dated 30.12.2019 passed by the Learned GRF, Jeypore in C.C. Case
 No. 151 of 2019.
- 3. The Representative of the Licensee-TPSODL submits that after disposal of the SLP(C) No. 19657 of 2023 filed by it before the Hon'ble Supreme Court of India, challenging the judgment dated 18.05.2023 of the Hon'ble High Court of Orissa in W.P. (C) No.13585 of 2020, the Respondent-Licensee has complied with the Order dated 30.12.2019 of the Learned GRF Jeypore passed in C.C. No.151 of 2019. Therefore, he prays before the Commission to close the present proceeding filed by the Petitioner under Section 142 of the Electricity Act, 2003.
- 4. The Learned Advocate appearing on behalf of the Petitioner submits that the Respondent-Licensee has not fully complied with the aforesaid order dated 30.12.2019 of the Learned GRF, Jeypore and therefore it is stated that the Respondent-Licensee be directed to act upon the Order dated 30.12.2019 passed by the Learned GRF, Jeypore in C. C. Case No.151 of 2019.
- 5. Upon hearing the parties, the Commission directs the Learned GRF, Jeypore to take up the matter in C. C. Case No.151 of 2019 and verify & pass order whether the order dated

- 30.12.2019 in above case has been complied with in letter and spirit. Therefore, the Registry is directed to forward the Petition along with all the relevant documents to the Learned GRF.
- 6. The parties are directed to appear before the Learned GRF, Jeypore on 10.06.2025 for next course of action in this matter.
