## **ORDER**

The Petitioner-M/s. SKGG Hostels (P) Ltd., Duarsuni, Hill Town, Bhawanipatna, Kalahandi has filed the present petition under Section 142 of the Electricity Act, 2003 alleging non-compliance of order dated 22.04.2024 of the Learned GRF, Bhawanipatna passed in C.C. Case No. 237 of 2023.

- 2. The Learned GRF, Bhawanipatna, in their order dated 22.04.2024 passed in C.C. Case No. 237 of 2023, had directed the Respondent-Licensee as under:
  - "i) To withdraw the TR Loss beyond four months from the month of supply, i.e. 06/2019. Which was raised against the consumer during LT billing.
  - ii) LT bill was raised twice from 07/2020 to 05/2021, accordingly EC bill needs to be rectified.
  - iii) Revised bill is to be served on the complainant within one month."
- 3. According to the Petitioner, they had approached the Commission in the same matter vide Case No.76 of 2024. In absence of the Representative of the Petitioner, the

Respondent-Licensee had submitted before the Commission that they had fully complied with the aforesaid order of the Learned GRF, Bhawanipatna. Accordingly, the Commission had disposed of the case vide its order dated 26.11.2024 with the observation that the Respondent-Licensee has already complied with the directions of the Learned GRF, Bhawanipatna passed in in C.C. Case No. 237 of 2023.

- 4. The Representative of the Petitioner submits that the Respondent-Licensee has not complied with the aforesaid order dated 22.04.2024 of the Learned GRF fully and correctly. The Respondent-Licensee has not submitted the revision statement and according to the Petitioner, the revised amount will be more than the amount reflected in the bill for the month of October, 2024 by the Respondent-Licensee.
- 5. The Representative of the Respondent-Licensee submits that they have complied with the aforesaid order of the Learned GRF fully and correctly as per the Regulations and the revised statement has been sent to the Petitioner through email dated 29.01.2025.
- 6. Upon hearing the parties, the Commission decides to refer the matter to the Learned GRF, Bhawanipatna to verify whether their order dated 22.04.2024 passed in C.C. Case No.237 of 2023 has been fully complied with or not.
- 7. The Registry is directed to send a copy of this order along with the copy of the Petition and reply of the Respondent-Licensee to the office of the Learned GRF, Bhawanipatna for necessary action at their end. Both the parties are directed to appear before the Learned GRF, Bhawanipatna on 21.04.2025 positively to present their submissions in the matter. The Learned GRF, Bhawanipatna is directed to submit their report before this Commission within a period of 15 days thereafter.
- 8. With the above observation, the case is disposed of.
