M/s. Mahaveer Fly Ash Bricks, Kulugaon, Samantarapur, Dist.-Jajpur has filed the present case under Section 142 of the Electricity Act, 2003 alleging non-compliance of Order dated 04.12.2023 of the Learned GRF, Jajpur Road passed in C.C. Case No. 285 of 2023. The Learned GRF, Jajpur Road while disposing of the C.C. Case No. 285 of 2023 has observed as follows:

"Opposite Party is directed to revise the MMFC claimed as per RST order applicable time to time and also in line with Regulation 117 of OERC Distribution (Conditions of Supply) Code, 2019.

Opposite party is directed to refund the cost of check meter including metering unit."

2. The Respondent-Licensee submits that in compliance with the order of the Learned GRF, Jajpur Road passed in C.C. Case No.285 of 2023, the Respondent-Licensee has sought necessary approval from the competent authority for refund of cost of check meter including metering unit. After obtaining the approval of the competent Authority on 10.04.2024, the Respondent-Licensee has taken steps for reflection of the same in the Electricity bill and copy of the revised bill has been served to the Petitioner-consumer on 20.04.2024.

- 3. We heard the parties at length in the virtual mode. In course of hearing, the Petitioner through the Authorized Representative intimated that the Petitioner does not agree to the compliance made by the Respondent-Licensee in as much as the revision of the bills is not made as per the order of the Learned GRF, Jajpur Road passed in C.C. Case No. 285 of 2023. At this stage, the Authorised Representative of the Petitioner submits to send back the matter to the Learned GRF, Jajpur Road to examine the issue regarding compliance of the impugned order.
- 4. Considering the submissions of the parties, the matter is sent to the Learned GRF, Jajpur Road, to examine whether its order dated 04.12.2023 passed in C.C. Case No.285 of 2023 is complied with or not in letter and spirit. As such, the Parties are directed to appear before the Learned GRF, Jajpur Road on 03.06.2024 for further instruction of the Learned GRF, Jajpur Road in this matter.
- 5. With the above observation, the case is disposed of. The Registry is directed to send a copy of this order to the office of the Learned GRF, Jajpur Road along with the copy of the Petition forthwith.
