This matter is taken up for hearing through hybrid arrangement.

- Shri R.K.Behera, the Authorized Representative of the Petitioner and Sri Chandrabhanu 2. Mohanty, Executive Engineer (Electrical), CDD-II, TPCODL -the Respondent do appear. The compliance report submitted by the Respondent-TPCODL is taken on record.
- The Petitioner had filed the present petition under Section 142 of the Electricity Act, 2003 3. alleging non-compliance of the order dated 19.02.2024 of the Learned GRF, Cuttack passed in C.C. Case No.08 of 2024. The Learned GRF, Cuttack while disposing of C.C. Case No.08 of 2024, has issued the following directions:
  - "1) The O.P. is directed to serve correct EC bill at appropriate tariff with CD 20KW from date of such power supply commencement.
  - The O.P. is directed to follow Regulation 128 and Regulation 129 of OERC (Conditions of Supply) Code, 2019 while considering enhancement of CD from 20KW to 35KW. The O.P. shall make necessary communication to the complainant in writing for enhancement of the contract demand accordingly."
- 4. The Commission, vide their interim order dated 11.06.2024, acceding to the request of the Respondent, had directed the Respondent-TPCODL to comply with the order dated 19.02.2024 of the Learned GRF, Cuttack passed in C.C. Case No.08 of 2024 at the earliest and submit the compliance report before this Commission.
- 5. In course of hearing, the Respondent-Licensee submits that the aforesaid order dated 19.02.2024 of the Learned GRF, Cuttack passed in C.C. Case No.08 of 2024 has already been complied with in letter & spirit and prays before the Commission for closing the present proceeding. The Authorised Representative of the Petitioner does not object for disposal of the case.
- 6. Accordingly, the Petition stands dropped & closed.
