## **ORDER**

This matter has been taken up for hearing through hybrid arrangement.

- 2. Shri Chandrabhanu Mohanty, Executive Engineer (Electrical), CDD-II, TPCODL, Badambadi -the Respondent herein does appear. None appears on behalf of the Petitioner-M/s. Fireking Industries. The compliance report submitted by the Respondent-licensee as per interim order dated 23.07.2024 of the Commission and the written submission of the Petitioner relating to such compliance in respect of the Order dated 21.03.2024 of the learned GRF, Cuttack passed in C.C. Case No.76 of 2024 by the Respondent-Licensee are taken on record.
- 3. The Petitioner has sought for the following reliefs:
  - to comply the order passed by the learned GRF, Cuttack in C.C.Case No.76 of 2024 and refund the security deposit amount along with interest payable thereof as per regulation 57 of the OERC (Conditions of Supply) Code, 2019. The interest should be calculated separately on amount paid on 12.04.2006 & amount paid on 01.02.2008 towards initial security deposit and Additional security deposit respectively;
  - to pay the additional interest @15% per annum to the Petitioner on the total Sd amount plus interest there thereof from 2006-07 to 2023-24 to till date as per regulation 58 of the OERC Supply Code, 2019.
- 4. The compliance report of the Respondent-Licensee in pursuance of the interim order dated 23.07.2024 of this Commission is as follows: -
  - "In pursuance of the order dated 23.07.2024 of the Respondent-Licensee has submitted that order dated 23.07.2024 of the Learned GRF, Cuttack has been fully complied with and the Security deposit amount of Rs.25,000.00 along with interest thereof for the period from FY 2006-07 to 2020-21(12.04.2006 to 31.05.2020) of Rs.21,809/- is credited to the consumer-Petitioner's Account against CA No.800452328(M118-00361) after obtaining necessary approval of the Head Office of the Respondent-licensee with intimation to the

- Petitioner-Consumer herein. Therefore, this Commission may drop the proceedings initiated under section 142 of the Electricity Act, 2003 against the Respondent-licensee."
- 5. We heard the Respondent-Licensee in absence of the Petitioner. It is stated that the instant Petition may be disposed of without contest as the Order dated 21.03.2024 of the learned GRF, Cuttack passed in C.C. Case No.76 of 2024 has already been complied with.
- 6. In view of the aforesaid submissions of the Respondent-Licensee, the case is disposed of.
