## **ORDER**

**Date of Hearing: 13.05.2025** 

This matter is taken up for hearing through hybrid arrangement.

2. M/s. Konark Suryanagari Pvt. Ltd. has filed the instant Petition under Section 86 (1) (b) & (e) of the Electricity Act, 2003 with the following prayers:

"It is most respectfully submitted before the Hon'ble Commission to give directions/instructions to OREDA and GRIDCO for allowing revised upward tariff or VGF for this 10 MW Konark Solar IPP which holds national importance for India and Odisha to show to the world about off-setting the conventional energy consumption of Konark sun Temple City achieving Net Zero Goal through Energy Transition."

3. The Petitioner, vide the letter dated 23.04.2025, has sought permission to withdraw the instant Petition. The contents of the said letter are as follows:

"We respectfully write to inform you that Konark Surya Nagri, through a formal affidavit, has confirmed the withdrawal of all pending cases filed against the Odisha Renewable Energy Development Agency (OREDA) with immediate effect from acceptance of this letter.

The affidavit further affirms that, in the event of any legal or regulatory matter arising under the name of Odisha Renewable Energy Development Agency (OREDA), the organization shall take full responsibility and be solely liable for the same.

Accordingly, we request that this submission be taken on record and that no further action or consideration be given to any such cases, past or pending, with respect to Konark Surya Nagri against OREDA."

- 4. In view of the submissions as aforesaid and upon hearing the parties in the matter, we allow the Petitioner to withdraw the Petition.
- 5. Accordingly, the Petition is disposed of as withdrawn.
