This matter is taken up for hearing through hybrid arrangement.

- 2. Shri A.K. Sahani, the Authorized Representative of the Petitioner and Shri Suresh Chandra Dash, Learned Advocate along with Shri Pramod Kumar Nayak, the Executive Engineer (Electrical), JED, Jajpur Road, TPNODL on behalf of the Respondent-Licensee do appear.
- 3. The Petitioner-M/s. Pradhan Industries Ltd. has filed the present petition under Section 142 of the Electricity Act, 2003 alleging non-compliance of order dated 01.03.2012 of the Learned Ombudsman-II passed in C.R. Case No.72 of 2011 arising out of order dated 31.10.2011 of the Learned GRF, Jajpur Road passed in C.C. Case No.546 of 2011 and the direction of the Hon'ble High Court of Orissa vide their order dated 24.07.2024 passed in W. P (C). No.10748 of 2012.

- 4. In course of hearing, the Learned Advocate for the Respondent-Licensee stated that the aforesaid order of the Learned Ombudsman-II passed in C.R. Case No.72 of 2011 has been complied with at their end. However, the revised bill has been sent to GRIDCO Ltd. for approval as it involves the period prior to vesting of the Distribution Licence. As soon as they obtain said approval from GRIDCO Ltd., the revised bill would be issued to the Petitioner.
- 5. In view of the above, we decide to close the matter with a direction to the Respondent-Licensee to pursue the matter with GRIDCO Ltd. and comply with the order dated 01.03.2012 of the Learned Ombudsman-II passed in C.R. Case No.72 of 2011 within a month hence and submit the compliance report before the Commission.
- 6. In case the Respondent-Licensee does not comply with the aforesaid order of the Learned Ombudsman-II, the Petitioner is at liberty to raise the matter before the Commission.
- 7. With the above directions, the present case is disposed of.
