The matter is taken up for hearing through hybrid arrangement.

- 2. Shri Rabin Kishore Behera, the Authorized Representative of the Petitioner-Shri Sadashiba Das and Shri Ashok Kumar Jena, the Executive Engineer (Electrical), the Representative of the Respondent-Licensee (TPCODL) do appear.
- 3. The Petitioner has sought for the following reliefs:
 - to implement the order dated 22.05.2024 of the Learned GRF, Paradeep passed in C.C Case No.GRF/JED/32 of 2024 and enhance the contract demand and replace a suitable service cable to draw load upto 84 KW;
 - ii. and may pass any other order(s), relief(s) as deem fit and proper.
- 4. In course of hearing, Shri Ashok Kumar Jena, the Executive Engineer (Electrical), JED, Jagatsinghpur-the Respondent-TPCODL submits that they have already complied with the order dated 22.05.2024 of the Learned GRF, Paradeep passed in C.C. Case No. GRF/JED/32/2024.
- 5. On the contrary, the Authorized Representative of the Petitioner submits that the aforesaid order is yet to be implemented by the Respondent-Licensee. However, both the parties

agree to remit the matter to the Learned GRF, Paradeep to examine regarding implementation of the order of the Learned GRF, Paradeep.

- 6. Considering the above submissions of the parties, the Commission remits the matter to the Learned GRF, Paradeep. The Learned GRF shall verify whether their order has been implemented by the Respondent-Licensee in letter and spirit. The GRF concerned shall hear the parties on implementation of their order and give their findings. If the GRF holds that their order has not been properly implemented, it shall spell out, what exactly needs further to be implemented.
- 7. The Registry is directed to send the copy of this order to the Learned GRF, Paradeep along with other relevant documents.
- 8. With the above observations and directions, the case is disposed of.
