Application under Section 142 of the Electricity Act,2003 alleging non-compliance of order dated 06.06.2018 of the Learned GRF, Balasore passed in C.C. Case No.117 of 2018 and also order dated 30.10.2018 of the learned Ombudsman-II passed in C.R. Case No.19/2018.

This matter has been taken up for hearing through hybrid arrangement.

- 2. Shri Rabin Kishore Behera, the Authorised Representative of M/s. Raja Agro Cold Storage and Shri Manoj Nayak, the Executive Engineer (Electrical), BED, TPNODL, Balasore -the Respondent herein do appear. The rejoinder to the reply of the Respondent-Licensee filed by the Petitioner is taken on record.
- 3. The Petitioner has sought for the following reliefs:
 - to implement the order passed by the learned GRF, Balasore in C.C. Case No.117 of 2018 and the order dated 30.10.2018 of the Learned Ombudsman-II passed in C.R. Case No.19 of 2018 and refund the amount taken illegally with 10% interest per annum till realization of the same as per direction of the Hon'ble High Court of Orissa in W.P.(C) No.15232 of 2018;
 - ii) And may pass any other order(s), relief(s) as deem fit and proper.
- 4. The compliance report of the Respondent-Licensee in pursuance of the interim order dated 15.10.2024 of this Commission, is as follows: -
 - "Upon hearing the parties, we direct the Petitioner to discuss with the Respondent-Licensee and verify the calculations made by them. The Respondent-Licensee is directed to explain their calculation to the Petitioner and submit the compliance report before the Commission on or before 29.10.2024 serving copy of the same on the Petitioner. The Petitioner is directed to file its rejoinder, if any, on the reply of the Respondent-Licensee on or before 05.11.2024".
- 5. We heard the Representative of the Petitioner and the Respondent-Licensee in the matter. As the Respondent-Licensee has not filed the compliance report as per direction of the

Commission vide its interim order dated 15.10.2024, the Respondent-Licensee is once again directed to comply with the order dated 06.06.2018 of the Learned GRF, Balasore passed in C.C. Case No.117 of 2018 and order dated 30.10.2018 of the Ombudsman-II passed in C.R. Case No.19 of 2018 read with the direction of the Hon'ble High Court of Orissa passed in W.P.(C) No.15232 of 2018, in letter and spirit within two months hence with copy to this Commission, failing which the Commission shall invoke Section 142 of the Electricity Act, 2003 and the erring officials shall be liable to penalty as deemed fit.

6. In view of the aforesaid directions to the Respondent-Licensee, the case is disposed of.
