This matter is taken up for hearing through hybrid arrangement.

- 2. Shri Rabin Kishore Behera, the Authorized Representative of the Petitioner-M/s. Raj Complex and the Respondent-Shri Jitendra Behera, the Executive Engineer (Electrical), BED, Balasore, TPNODL do appear. The Memo of withdrawal of present case filed by the Authorized Representative of the Petitioner today is taken on record.
- 3. In its application, the Petitioner had prayed for the following reliefs:
  - i. to implement the order dated 28.09.2018 of the Learned GRF, Balasore passed in C.C. Case No.165 of 2018 and order dated 05.01.2019 of the learned Ombudsman-II passed in C.R. Case No.41/2018 and order dated 11.05.2023 of the Hon'ble High Court of Orissa passed in W.P.(C) No.11396 of 2019;
  - ii. to penalize the Respondent under Section 142 of the Electricity Act,2003 for the delay in comply with the above orders of the Learned Forums;
  - iii. and may pass any other order(s), direction(s), relief(s) as deem fit and proper.
- 4. At the outset of the hearing, the Representative of the Respondent Licensee submitted that they have already complied with the directions in the aforesaid orders passed by the

Learned GRF, Balasore, the Learned Ombudsman-II and also the Hon'ble High Court of Orissa. Accordingly, the present case may be disposed of.

- 5. The Authorized Representative of the Petitioner does not resist the above submissions of the Respondent-Licensee and to that effect, a memo has been filed by him before the Commission in course of hearing.
- 6. In view of the above submissions of the parties, the present case is disposed of.
